- **3.** *Non-Personal Interests* refers to fees or grants paid to a GOLD Committee member (or the Department/Institution on behalf of a GOLD member) and used for research, education, equipment, salaries, etc.

For each category, items are included in one of two categories: payment or service is valued in excess of \$10,000 (US) but less than \$10,000 and payment or service is valued in excess of \$10,000. The information disclosed by each member of the Board of Directors for the year 2014 is presented in an effort to be as transparent as possible. If the member serves on a Data Safety Monitoring Board, this is so indicated by the designation (DSMB).
